

Heart Failure in Ambulatory Care: What's New, What's Next?

Overview: This continuing education presentation is designed to equip pharmacists and other health care professionals with evidence-based strategies for optimizing heart failure care in ambulatory care settings. Collin will focus on heart failure with reduced ejection fraction (HFrEF), highlighting guideline-directed medical therapy (GDMT) and practical ambulatory care tips for improving patient outcomes. Joseph will address heart failure with preserved ejection fraction (HFpEF), emphasizing emerging pharmacologic therapies and strategies for integrating these treatments into ambulatory care workflows.

3. Select a GDMT regimen for a patient with heart failure with preserved ejection fraction (HFpEF).
4. Identify the updated literature surrounding HFpEF.
